This Pioneer Shipment & India Registration Program Agreement ("Agreement") governs the participation of the Producer/Supplier ("Producer") in the SWISS WINE INDIA / TEPA.swiss® Pioneer Shipment & India Registration Program.

Commercial procurement, purchase orders, importation and payment obligations are handled by:

acting as:

- Importer of Record
- purchasing entity
- India regulatory operator
- customs and compliance entity

World Wide Services Group Ltd. / TEPA.swiss® acts exclusively as:

- market-entry facilitator
- strategic coordination entity
- operational coordination platform
- trade activation and enablement partner

and is not the purchasing entity for wine products unless explicitly agreed otherwise in writing.

The purpose of this Agreement is the controlled execution of an initial pilot shipment of Swiss wine products to India for:

- FSSAI registration and compliance procedures
- market validation
- trade and hospitality testing
- importer onboarding
- logistics validation
- product positioning and promotional activities
- operational validation of the India supply chain

The parties acknowledge that the Program constitutes an exploratory and market-development initiative and does not represent a guaranteed commercial rollout.

The Pioneer Shipment Program is intended to establish the operational, regulatory and commercial foundation for potential future market development activities in India.

The Producer agrees to provide the products and quantities defined in the applicable:

- RFQ
- Purchase Order
- Shipment Confirmation
- TEPA.swiss® System confirmation
- related procurement documentation

Unless otherwise agreed in writing, the initial shipment shall be treated as:

for registration and validation purposes only.

The parties acknowledge that the initial shipment quantities are intentionally limited and may not reflect future commercial volumes.

Invoices for wine products shall be issued by the Producer directly to:

unless otherwise agreed in writing.

Swintra Ventures Pvt. Ltd. shall act as:

- purchasing entity
- Importer of Record
- India regulatory entity
- customs processing entity

Commercial payment terms shall be defined in the applicable Purchase Order, invoice confirmation or mutually agreed procurement documentation.

WWSG / TEPA.swiss® does not assume payment obligations for wine purchases unless explicitly agreed otherwise in writing.

Neither Swintra Ventures Pvt. Ltd. nor WWSG / TEPA.swiss® guarantees:

- commercial success
- market acceptance
- regulatory approval
- future orders
- minimum purchase quantities

- exclusivity
- distributor listings
- hospitality placements
- retail listings
- import approval timelines

All activities are conducted on a commercially reasonable best-effort basis within a developing international market environment.

The Producer acknowledges that:

- Indian import regulations may change without notice
- FSSAI approval processes may be delayed, suspended or rejected
- laboratory analysis may be required
- vintage-specific approvals may apply
- additional declarations or certifications may be requested by authorities
- customs procedures may vary by shipment and state

The parties acknowledge that India regulatory onboarding, FSSAI approval procedures and market validation timelines may vary substantially and may extend beyond initial estimated planning assumptions.

Neither Swintra Ventures Pvt. Ltd. nor WWSG / TEPA.swiss® shall be liable for delays, refusals or regulatory rejections arising from Indian compliance procedures.

The Producer shall provide accurate and complete:

- technical sheets
- allergen declarations
- origin data
- bottling information
- alcohol percentages
- vintage information
- barcode information
- certifications
- export-relevant product data
- legally required declarations

The Producer remains responsible for the correctness and legality of source product information supplied.

WWSG / TEPA.swiss® and its operational partners may adapt:

- labels
- QR codes
- supplementary compliance elements
- India-specific back labels
- packaging information

for Indian import and regulatory requirements.

Unless otherwise agreed in writing, shipments shall be conducted under:

or other mutually agreed Incoterms.

Transit times, customs clearance durations, bonded warehouse handling and regulatory processing may vary significantly.

All timelines communicated during the Program shall be considered indicative only.

Risk of loss or damage transfers according to the agreed Incoterm.

Neither Swintra Ventures Pvt. Ltd. nor WWSG / TEPA.swiss® shall be liable for:

- customs holds
- governmental actions

Ownership of trademarks and intellectual property remains with the Producer.

Operational coordination and status communication may be conducted through:

- the TEPA.swiss® Platform
- email communication
- designated coordination channels
- procurement workflows
- shipment coordination processes

Electronic approvals, portal confirmations and digitally exchanged procurement documents may be treated as operationally binding communications.

The parties agree to cooperate in good faith throughout the Pioneer Shipment and India registration process.

Both parties acknowledge that the Program involves operational, regulatory and market-development uncertainties that require constructive coordination and commercially reasonable cooperation.

Commercial pricing, procurement discussions, importer discussions, market-development discussions and strategic information exchanged between the parties shall be treated confidentially unless disclosure is required by law or regulatory authorities.

Nothing in this Agreement creates:

- an exclusive distribution relationship
- a joint venture
- a legal partnership
- an employment relationship
- agency authority
- fiduciary relationship

between the parties.

Either party may discontinue participation in future Pioneer Shipment activities upon written notice, provided that already confirmed commercial obligations remain unaffected.

Termination of future participation shall not affect:

- confirmed Purchase Orders
- outstanding invoices
- regulatory processes already initiated
- existing confidentiality obligations

To the maximum extent permitted by law, neither Swintra Ventures Pvt. Ltd. nor WWSG / TEPA.swiss® shall be liable for:

- indirect damages
- consequential damages
- loss of profits
- loss of market opportunity
- shipment delays
- failed registrations
- customs actions
- market underperformance
- hospitality onboarding delays
- third-party failures

Total liability shall in all cases be limited to the value of the directly affected shipment.

This Agreement shall be governed exclusively by the laws of Switzerland.

Exclusive place of jurisdiction shall be Switzerland.

Participation in the Pioneer Shipment & India Registration Program, acceptance of RFQs, Purchase Orders, shipment coordination activities or operational confirmations through the TEPA.swiss® System constitutes acceptance of these Terms & Conditions unless superseded by a separately signed written agreement.
